The Hon. Mayor Joseph P. Tursi called meeting to order. HFD Chief Irving Strysko led in the Salute to the Flag.

<u>Police Commissioner's Report</u> –

Police Commissioner Mayor Tursi reported that a Ramapo Police Officer had stopped by the Village Office on 7/7/2022 to advise of the increase in larcenies and auto thefts. Residents should remove keys/fobs from vehicles and to lock doors. -Trustee Tarantino reported the Ramapo Police responded very quickly to a call she had placed on Sunday.

(The Village Board received a copy of same). Mr. Madden will forward the email to the Maintenance Dept. Matter remains pending.

Mayor Tursi reported he had received an email from Bill Madden of Veolia – RE: Purchase of the Village water system.

DPW Report - DPW Supt. Conklin

<u>LED Lighting in Village Building</u> – HFD Building/Community Room – Contractor: TASS of New York, Inc. – The remainder of the lights have been delivered. Installation may be done on Saturday, 7/16/2022. DPW Supt. stated he kept documenting the project and will not sign off until all lights are installed in accordance with the contract.

-Deputy Mayor Tarantino stated that the contractor had left the building in an unacceptable condition and questioned DPW Supt. Conklin if the old lighting and trash that were strewn throughout the rooms had been removed.

Supt. Conklin stated that the contractor separated and loaded the items onto DPW trucks for proper disposal.

The Town of Ramapo is a party on the Certioraris and will have the properties appraised. He will meeting with Village Assessor Scott Shedler to discuss TOKNY Realty.

<u>4/22/22 Revised Draft of Local Law for Amendment of Zoning Law and Comprehensive Plan</u> – A Workshop to review the draft zoning local law was held at 6:30PM this evening.
