Village Water System .

-Veolia (formerly SUEZ Water New York) - Repair to 4th St. Valve (4/18-20/2022) - In accordance with the 5/10/2022 Village Board approval, a bill was sent to SUEZ/Veolia for services rendered by the DPW staff in association with the valve repair. In response, a 5/12/2022 email was received from Bill Madden of Veolia stating that "VWNY is not responsible for labor performed by Hillburn staff on the Hillburn water system".
