# Auditor's Report – FYE 5/31/23 – Berard & Associates CPA's P.C.

#### Village Engineer's Report – Engineer Mancuso reported:

 $\frac{6^{\text{th}} \text{ Street Culvert}}{1}$  – Project has been advertised for bid - Bid return date: 11/14/2023. As of this date, bid specifications have been issued to seven companies. A Pre-Bid Meeting/Walk Through will be held on 11/1/2023. The project will require some means of access (i.e. temporary bridge).

## **Board Meeting**

<u>RE:</u> NYS DEC Permit Restriction: Trout Time of Year - No in-stream work is allowed between Oct.  $1^{st}$  and Apr.  $30^{th}$  – The current deadline to complete the project is 3/4/2024. Due to this restriction, a second extension request will be filed with FEMA.

5<sup>th</sup> St. DPW Garage – Specifications are near completion.

-Mayor Tursi reported that funding for this project was discussed at the workshop meeting held today with the Village's Bond Counsel, Robert Smith of Hawkins, Delafield & Wood; and financial advisors Noah Nadelson & Joseph Nocerino of Munistat Services, Inc.

-<u>Veterans Memorial Park Pond</u> – Phase I of project is being finalized. This will determine if the new well will provide adequate water.

<u>2023 Road Improvements</u> - Engineer Mancuso reported that the contractor, Tilcon, is working in Suffern. She is waiting for confirmation of a start-up date.

<u>**RC Hazard Mitigation Plan 2024 Update**</u> – Engineer Mancuso will assist the Village Clerk in completing the required questionnaires.

#### Proposed Bond

Mayor Tursi reported that the Bond was originally going to fund four projects/purchases. However, upon consideration of alternate funding, and subsequent to meeting with the financial advisor, the following was determined as follows:

- 5<sup>th</sup> Street DPW Garage A Bond Resolution will be prepared.
- Purchase of Garbage Truck A Bond Resolution will be prepared. (Due to the delivery date of the Garbage Truck is estimated at 18-24 months, securing of funds will be postponed)
- Veterans Memorial Park Pond Rehabilitation Phase I Funding: Balance of funding in the ARPA/SLFRF Grant and SAM Grant #24595.
- Purchase of Dump Truck Purchase will be funded through the Village's Special Sewer Account, as per Resolution adopted on 10/19/2023

#### Village Attorney's Report – Village Attorney Terry Rice reported

-Judge Eisenpress signed the amended Order to Remediate the Site, that include new deadline dates for compliance.

-The Cianciaruso Defendants have changed their Attorney. Mr. Lechins has been replaced by Valerie Palma DeLuisi. Attorney DeLuisi has filed a Notice of Appeal from the Court's 9/18/2023 Decision and Order which dismissed their Contempt application against the Village.
