-RE: Access Stipulation - An email was received from Attorney Rice advising that Village property does not need to be crossed over to access the Outdoor Properties property or Thruway property.

Noved LOMR-F (Letter of Map Revision) filed on 2/7/2023 – Denied by Floodplain Administrator on 2/10/2023

-Order to Show Cause and Supporting Papers to hold Village of Hillburn (Plaintiffs) in Contempt of Court filed by the Attorney for Nicholas Cianciaruso, NAC Maintenance, Inc., Craig Flanagan, Jr., Outdoor Properties, LLC, Douglas L. VanSchaik, William Cianciaruso a/k/a/ Bill Diamond and Diamond Truck Service, Defendants.

-A Hearing is scheduled for 11/22/2023 - Attorney Rice sent a 9/12/2023 letter to Judge Eisenpress contending that the hearing is not mandated due to the Motion for Contempt is frivolous and inapplicable as a matter of law. Additionally, he requested the Judge dismiss the Contempt Application and vacate the Stay of the Remediation Order. Further, if the Judge rejects his argument, he requested the hearing be rescheduled.

-Trustee Tarantino questioned how far away the contaminated fill is from the water aquifer.

-Attorney Rice replied that it is more of a concern to the northern New Jersey communities, as it would flow downstream. Originally, based on the Court's earlier Order, test pits were dug and the analysis of the contents revealed contaminants. The Engineer's report, that is included in the May 2023 Remediation Order, requires additional test pits to acquire a better understanding of the location(s) of the contaminants.

-Trustee Tarantino stated the Village should be going after all of the Defendants on the Order for Remediation. (Nicholas Cianciaruso, NAC Maintenance, Inc., Craig Flanagan, Jr., Outdoor Properties, LLC, Douglas L. VanSchaik, William Cianciaruso a/k/a/ Bill Diamond and Diamond Truck Service, Defendants.

-Attorney Rice stated that monetary Judgements are already in effect against the Cianciarusos (approx. \$700,000), and the owner of the property, Douglas L. Van Schaik (aprox. \$400,000). Craig Flanagan, Jr. had defaulted at the beginning of the case and already has an Order against him; however, he will discuss with the Village Board the feasibility of seeking a monetary Judgement against Mr. Flanagan.

-Trustee McNally stated his opinion that it is an environmental crime and the perpetrators should be arrested. Trustee McNally also questioned if any legal action can be taken against the NYS DEC for failing to pursue this matter. Attorney Rice replied no.

-Jimi Van Dunk (26 Boulder Ave.) readdressed his complaint made at the 8/8/2023 Board Meeting regarding the installation of "No Parking" signs on Boulder Ave; and his opinion that racism was a motive for the DPW Supt.'s actions. -The Village Board stated they have known Supt. Conklin for many years and can attest that he is not racist.

-DPW Supt. Conklin stated that no racism or malice influenced his decision regarding the placement of No Parking signs on Boulder Ave. Further, no sign was installed by his home, only yellow markings were placed on the roadway.

-As recommended by Trustee Tarantino, Mr. Van Dunk was requested to contact the Village Office to schedule a meeting to discuss this matter with the Village Board and DPW Supt. Conklin.

Carla Alexander (31 Rockland Avenue) questioned if NYS or the Village installed the signs prohibiting the parking of trucks on Rte. 17. Mayor Tursi stated that, in response to complaints received, the Village adopted Local Law No. 2 of 2023, prohibiting trucks weighing 5 tons or more from parking on streets in the Village of Hillburn.

June Van Dunk (151 Sixth St) requested police presence in the area of Boulder Ave. and Sixth St. from approx. 2:30 – 3:30PM, when the elementary children get off the school bus. On several occasions, she has witnessed young men from 22 Boulder Avenue soliciting drugs and appearing to be in an intoxicated state. She has filed several police reports.

-Mayor Tursi stated he will contact the Ramapo Police regarding this matter.

Tim Williams (31 Sixth St) recommended the establishment of an Architectural Design Committee to regulate the types of homes built in the Village.

Adoption Resolution

BE IT ENACTED by the Board of Trustees of the Village of Hillburn as follows:

WHEREAS, the Village of Hillburn adopted a Comprehensive Plan for the Village in 2020 which, among other things, created a Local Shopping (LS) zoning district to allow for uses that would meet the day-today local shopping needs of Hillburn residents and businesses; and

WHEREAS, in the interim, the Village has found that it needs to ensure that the LS zoning district allows uses that were historically permitted and are still presently located in the district, so that the zoning does not unintentionally erode the Village tax base through lack of demand for uses that are presently allowed in the LS zone and deprive the owners of the respective property economically viable uses of their properties; and

WHEREAS, the Village desires to continue to encourage the LS uses allowed in the LS zone, but to also allow uses that were allowed within the HC Highway Commercial zone, which was the zoning district in place prior to creation of the LS zone; and

WHEREAS, it has also been proposed to rezone a portion of one parcel which is presently zoned R-9 to the LS zone so that it is consistent with the remainder of the LS zoning for said parcel and the existing use of the parcel; and

WHEREAS, pursuant to § 250-77 of the Zoning Law, the proposed local law was referred to the Village of Hillburn Planning Board on July 11, 2023; and

WHEREAS, on August 17, 2023, the Village of Hillburn Planning Board recommended adoption of the local law; and

WHEREAS, pursuant to § 239-m of the General Municipal Law and § 250-78 of the Zoning Law, the proposed local law was referred to the Rockland County Department of Planning on July 12, 2023; and

WHEREAS, by letter dated August 4, 2023, the Rockland County Department of Planning made various recommendations; and

WHEREAS, a notice of the public hearing on said local law to be held on September 12, 2023 was timely published in the Journal News on August 28, 2023; and

WHEREAS, the Village planner prepared an Environmental Assessment Form for the proposed local law which has been reviewed by the Board of Trustees; and

WHEREAS, the Board of Trustees adopted a Negative Declaration pursuant to SEQRA on September 12, 2023.

WHEREAS, the comments of the public were received by the Board of Trustees at the September 12, 2023 public hearing and the hearing was closed; and

NOW, THEREFORE, BE IT RESOLVED by the Board of Trustees of the Village of Hillburn that, as related in the previously adopted Negative Declaration, the adoption of the proposed local law will not have a significant adverse effect on the environment; and

BE IT FURTHER RESOLVED that the proposal complies with the recommendations of the Department of Planning August 4, 2023 letter; and

BE IT FURTHER RESOLVED, that the Board of Trustees finds that all procedural requirements for the adoption of said local law have been satisfied; and

BE IT FURTHER RESOLVED the Board of Trustees finds that the proposed local law is consistent with the Village's comprehensive plan; and

BE IT FURTHER RESOLVED that it is in the overall public interest of the Village of Hillburn to adopt said local; and

BE IT FURTHER RESOLVED, that the rezoning of a portion of the parcel known and designated on the Tax Map of the Village of Hillburn as Section 47.14, Block 2, Lot 42 from a R-9 zoning designation to LS is subject to and conditioned upon the owner of the property applying to and obtaining amended site plan approval for the installation of a 15-foot landscaped buffer along the rear of the property and any other portion of the property required by the Planning Board within 30 days of amended site plan approval, unless such time is extended by the Planning Board because of the season or weather.

BE IT FURTHER RESOLVED that Introductory Local Law No. 4, "A Local Law Amending Chapter 250 of the Code of the Village of Hillburn, the Hillburn Zoning Local Law," is hereby adopted as Local Law No. 4 of 2023. Said Local Law will take effect immediately upon filing with the Secretary of State.
